## **FALL RECREATIONAL SOCCER LEAGUES**

### **2010 BRINGS A NEW PARTNERSHIP:**

The BASC and the Burlington Area Community YMCA-YWCA have come together in a collaborative initiative to deliver a joint recreational league program beginning in the Fall of the 2010. This joint partnership will greatly enhance the soccer skills of our area youth in order to perpetuate the game of soccer at all age levels. This program will allow us to conduct a recreational league without duplicating services while jointly sharing responsibilities. This merger will strengthen the presence of soccer in Southeast Iowa.

Through the partnership, the Burlington Area Community YMCA-YWCA will be the lead on administrative functions including the handling and processing of all league registrations. The BASC will oversee game day operations as well as provide the resources necessary to train coaches and referees. All league games will be held at the Burlington Rec-Plex. The Burlington Area Community YMCA-YWCA members will continue to receive a discounted registration fee.

The Burlington Area Soccer Club also offers a competitive traveling program (Elite) that will be conducted separately from the joint recreational program. This program is for boys and girls ages 8 and up. The current Elite traveling program will be undergoing a few modifications as a result of the YMCA merger. 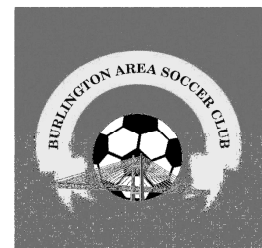
