Participants (or parent/guardian) must notify their private lesson instructor at least **24 hours** in advance of the scheduled lesson if needing to cancel. All participants will be charged for one lesson if 24-hour notice is not given. Those participating in semi-private lessons (2-3 students) must also notify their instructor at least 24 hours in advance. If one student misses a lesson, while the others attend the lesson, it will be counted as a lesson for ALL gymnasts in the semi-private lesson, not just the one(s) that attended that day. Participants must contact their coach directly to cancel.
